Voodafone Group Plc ("Voodafone") announces today that it has purchased the following number of its ordinary shares of £0.05 (20p) each from Goldman Sachs International ("GSI"). Such purchase was effected pursuant to an acquisition authority by Voodafone on 27 August 2024, as announced on 27 August 2024 (the "Programme").

As part of the Programme, GSI purchased Voodafone 21,880,730 ordinary shares on 05 November 2024. Such purchase was effected pursuant to an acquisition authority by Voodafone on 27 August 2024, as announced on 27 August 2024 (the "Programme").

Voodafone intends to hold the purchased shares in treasury. Following the purchase of these shares, Voodafone holds 2,162,627 of its ordinary shares in treasury and has 24,043,330 ordinary shares in issue (excluding treasury shares).

As part of the Programme, GSI purchased Voodafone 21,880,730 ordinary shares on 05 November 2024. Such purchase was effected pursuant to an acquisition authority by Voodafone on 27 August 2024, as announced on 27 August 2024 (the "Programme").

Voodafone's principal securities for purchase under the Programme are its ordinary shares. A schedule of individual trades carried out by Goldman Sachs on 05 November 2024 is set out below.
