Vodafone Group Plc ("**Vodafone**") announces today that it has purchased the following number of its ordinary shares of US\$0.20<sup>20/21</sup> each from Citigroup Global Markets Limited ("**Citi**"). Such purchase was effected pursuant to instructions issued by Vodafone on 14 November 2024, as announced on 14 November 2024 (the "**Programme**");

Vodafone intends to hold the purchased shares in treasury. Following the purchase of these shares, Vodafone holds 1,708,172,719 of its ordinary shares in treasury and has 25,541,223,709 ordinary shares in issue (excluding treasury shares).

As part of the Programme, Citi purchases Vodafone (213800TB53ELEUKM7Q61) ordinary shares and sells such shares to Vodafone. In connection with the above purchases, on 24 December 2024 Citi (as riskless principal) elected to purchase 12,300,000 Vodafone ordinary shares to sell to Vodafone. A schedule of individual trades carried out by Citi on 24 December 2024 is set out below.
